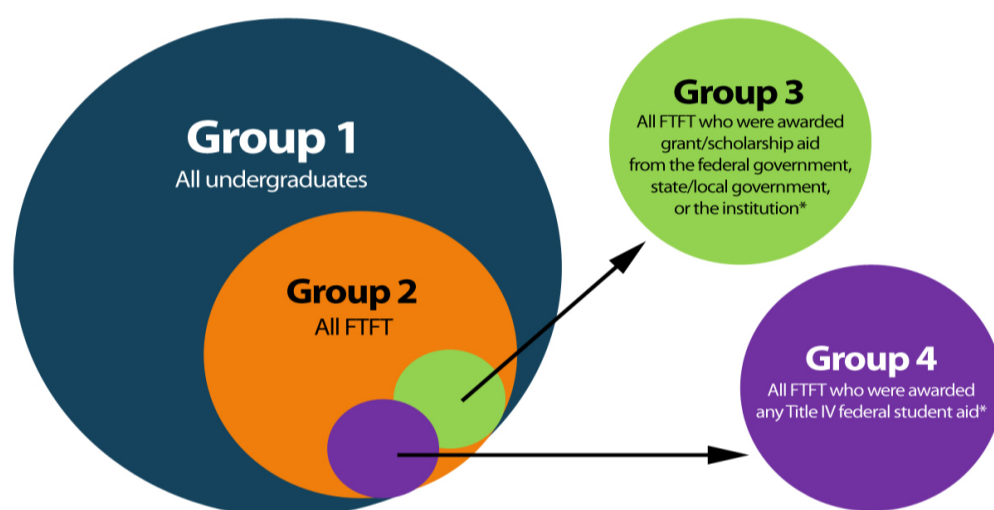
Overview
