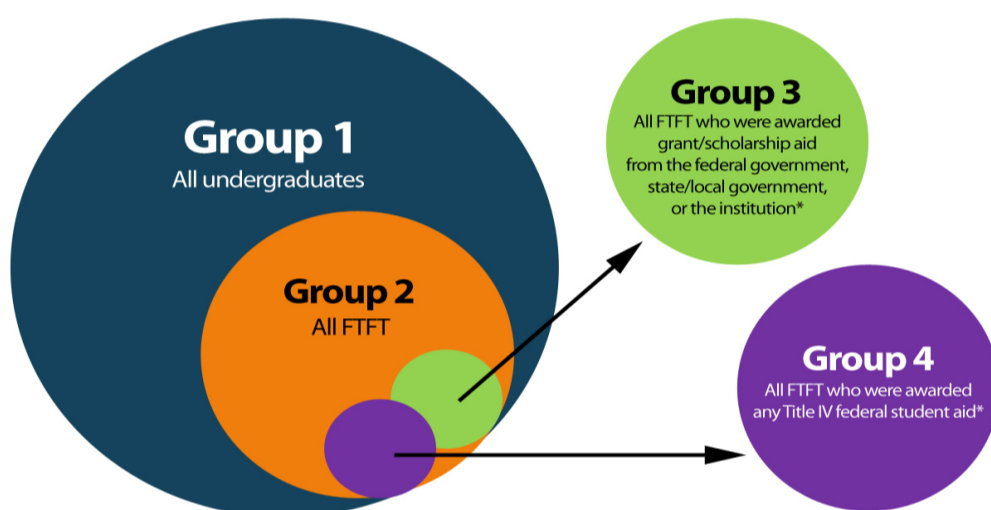
Overview

IPEDS Student Financial Aid Component Overview - Public Academic Reporters

Data Reporting Reminders:

- COA Revisions
